





Conference Report: 2018 BRICA Istanbul Summit Nov.13, 2018



2018 Belt and Road Industrial and Commercial Alliance (BRICA) Istanbul Summit (Oct 18-19, 2018, Istanbul, Turkey)

On October 18-19, Belt and Road Industrial and Commercial Alliance (BRICA) Istanbul Summit co-hosted by CFIE and TÜSİAD in collaboration with BRICA Secretariat was successfully held in Istanbul, Turkey, marking the second high-level multinational business event within the BRICA cooperative framework with broad member participation.

Background

Since its establishment on June 16, 2016, BRICA has extended its membership to 31 renowned and leading industrial and commercial organizations from 29 countries and regions. Within this cooperative framework, a number of bilateral and multilateral activities have been successfully held with BRICA annual summit being the most important and influential among them all. With Turkey's high interest in engaging the Belt and Road Initiative, TÜSİAD as the founding BRICA member applied to host the BRICA Istanbul Summit 2018 (www.bricaistanbul.com). Highlights

The summit broadly engaged 750 high-level business representatives from 27 countries & regions, including CFIE's high-level business delegation of approximately 50 representatives (including 10 speakers) from leading Chinese enterprises from a variety of sectors: automotive, energy, machinery, electronics, transportation, asset management etc...



In the two-day event, delegates discussed the present and prospects of the Belt and Road Initiative from a full set of perspectives while exploring business opportunities in Turkey, China and BRICA member states and discussing how to avail the BRICA cooperative framework to further facilitate bilateral and multilateral cooperation.

On the first day of the summit, Treasury and Finance Minister of Turkey Berat Albayrak (Photo 1); Ambassador of the People's Republic of China Yu Hongyang; Chairman of TÜSİAD Erol Bilecik, Executive Vice Chairman and Secretary General of CFIE & BRICA Xiong Meng, President of the European Bank for Reconstruction and Development Suma Chakrabarti and President of TÜSİAD China Network Korhan Kurdoğlu made the opening speeches.
